## **RENTAL CHARGES**

- Daily Rental fee of \$50 per day.
- \$200 Refundable deposit.
- \$15 Insurance charges if we provide insurance.
- Our payment method is through Zelle, CashApp, or PayPal or any other payment platform as agreed by both parties.
- We have a minimum of 2days initial Rental period to start the rental. After that the vehicle is available for daily renewal after the expiration of the initial rental period.
- We have a policy of unlimited mileage usage on all our cars.
- The car is delivered in good working condition and a pre rental inspection has been conducted and completed.

## **FUEL POLICY**

The gas should be returned to the gas level when the car is at pick up, additional charges may apply if fuel is less than what it is at pick up.

## **USE RESTRICTIONS**

The Renter agrees as follows:

- Not to drive outside State/country without a written consent and agreement.

- That he/she will be the only person driving the vehicle.
- Not to allow any unauthorized person to drive the vehicle.
- Not to use the vehicle for racing, towing or illegal activities.

## **INSURANCE**

Insurance shall be provided by the Renter throughout the rental period, which shall cover any damage or loss to the car and Third parties. We at **BUTTINS Rentals** provide **only property damage insurance (loss to our car)** to all our renters with a payment of an insurance fee, but if property damage insurance were provided by the Renter, then:

- The Renter shall provide evidence of insurance covering the car in case of collision and property damage.
- Non-provision of up-to-date proof of insurance shall automatically terminate the rentals.

## **LIABILITY AND INDEMNITY**

Renter is liable for any damages, loss, or theft of the vehicle during the rental period unless otherwise covered by insurance. The Renter agrees to indemnify the owner of all claims, losses or damages.

The Renter agrees to indemnify the owner of any toll charges or any violation whatsoever incurred during the rental period.

## **TERMINATION**

- BUTTINS RENTALS reserves the right to terminate this agreement if the terms are violated.
- Both parties have the right to terminate the rental agreement anytime without termination fees.
- At termination, the car should be returned by the Renter to the owner under the conditions the car is when it is rented.

**Other Terms and Conditions:**

- The owner shall bear the cost of maintaining the vehicle throughout the rental period.
- The vehicle must be kept clean throughout the rental period and at drop off, failure to clean the car attracts a cleaning fee of \$50.
- No smoking/vaping inside the car. This attracts a cleaning charge of \$200.
